- a. 19.1.5 AA policies Players will be evaluated by independent and qualified evaluators.
- b. 19.1.4 SPRA will select qualified coaches prior to team selection.
- c. 19.1.51 Athletes will be selected based on their ability to compete at the AA level as determined by evaluations, the AA director, coaches and selection committee.
 - d. 19.1.5.2 All levels will be given to SPRA players over non-resident players.
 - Section 29.1 Social media policy and procedures has been added to SPRA policies.
 - Stacey Heinish made a motion to accept all changes and new additions to SPRA policies and procedures. Sarah Strickler 2nds the motion. All in favor. Motion carried.
